This form allows you to nominate beneficiaries to receive lump sum benefits in respect of the Unilever UK Pension Fund in the event of your death.

Any nomination form you submit will replace any hardcopy or online form that you have previously completed.

You may nominate anyone including an organisation such as a charity. The Trustees will consider your wishes but they do not have to follow your instructions if you nominate someone who is not close family (spouse, civil partner, children, grandchildren, brothers or sisters, parents or grandparents). If you do nominate close family, the Trustees won't be able to consider any changes in your circumstances unless you were single when you completed the form and you subsequently got married. It is therefore important to update your nomination form if your circumstances change (e.g. if you have children).
